Consignment Information

Certified Coins: GreatCollections welcomes coins graded by PCGS, CACG, NGC, ANACS and ICG coins, including U.S. and World Coins, GSA Dollars, Redfield Dollars, Details, Tokens and Physical Crypto collectibles.

Raw Coins: The GreatCollections Grade & Auction program is for raw coins consigned to GreatCollections, which extends our discounted rates for coin grading directly to our members. We will process/review, and then submit to the grading service(s) under our account. *All raw coins consigned will be graded by one of the services on the front of this form. GreatCollections does not currently accept raw coins to sell as raw coins. GreatCollections is not responsible for any grade or action by any third-party grading service.*

Grading Services Options: We are authorized dealers at PCGS, CACG, NGC and ANACS and offer several different service levels depending upon the approximate value of the coin and processing time (in business days) by the grading services. Please note, processing times are approximate only, vary from time-to-time, and are from the time GreatCollections delivers your coins to the grading service. While PCGS is local to our office in Irvine, we will ship raw coins to CACG, NGC and ANACS, so the shipping time to/from is additional to our estimates.

Errors, Large Format, Rarities: The grading rates/services listed cover the most common coin submissions/consignments. At PCGS, CACG, NGC and ANACS certain errors, large format coins, first strike/first day of issue designation and rarities (coins worth more than \$100,000-\$125,000) may need to be graded under a different service at a different rate.

Varieties: Major and minor varieties can be attributed by the grading services. At PCGS, CACG and NGC, varieties add \$18 to the grading fee. At ANACS, varieties are included in the grading fee.

VSS Variety Attributions: VSS recognizes thousands of varieties and can place a label on the reverse of the holder for a nominal cost of \$15 per coin. This service takes approximately 10-14 days. To request coins to be reviewed by VSS, please note under special instructions on the front of this form.

CAC Sticker: CAC is a third-party grade verifier founded by John Albanese that reviews PCGS and NGC-graded coins (excluding moderns). GreatCollections is an authorized submitter and can arrange CAC to review your coins prior to listing in auction. The process takes approximately 10-20 days. Cost is \$22 for coins up to \$3,000, \$68 for coins valued at \$3,001-\$10,000 and \$150 for coins valued \$10,001 - \$125,000. All CAC submissions are subject to a \$10 CAC handling fee per invoice. All shipping/insurance fees between GC and CAC are paid by GC.

Listing Fees: GreatCollections listing fees are based on the following schedule and are charged the first time the coin is listed:

Seller's Fees: Our Seller's fees are a low 5% for coins up to \$1,000 and 0% for coins over \$1,000.

Cash Advances: We offer generous cash advances for all consignments at a competitive interest rate. Please check the box on the front of this form (below the signature line) and we will contact you as soon as we have reviewed your consignment. Once an advance has been paid to Consignor, Consignor may not withdraw any coin/item for any reason prior to repayment of the advance.

Consignment Terms & Conditions

1. Consignor agrees that the Auction shall be conducted online by GreatCollections according to the Terms and Conditions published at www.greatcollections.com/terms. This agreement is subject to Arbitration.

2. Consignor warrants that: (1) Consignor is the legal owner of and has full title and interest in the coins/items consigned to GreatCollections; (2) all coins/items consigned to GreatCollections are free and clear of any liens, encumbrances, security interests or contract rights restricting the unconditional right to sell all rights, title and interest in and to such coin/item; and (3) all consigned coins/items are authentic and in respect to certified coins, holders have not been tampered with or resealed.

3. Consignor agrees to pay GreatCollections a Listing Fee for each coins/items offered by Auction and for coins/items sold, a Seller's Fee. All fees are detailed on the reverse of the Consignment Agreement.

4. Consignor acknowledges that the Hammer Price is the final bid price accepted by the Auctioneer. The Hammer Price does not include the Buyer's Fee, which GreatCollections retains in full.

5. GreatCollections has the right in its sole discretion to reject any Consignment, to cancel any Auction, to postpone or change the date/time of Auction and/or to rescind any sale. GreatCollections also reserves the right in its sole discretion to cancel or reject any bidder from bidding, when we believe it is not in the Consignor's and/or GreatCollections' best interest.

6. In the event GreatCollections believes that any consigned item may contain a fake grading service holder and/or label, even if the encapsulated item itself is believed to be genuine, GreatCollections reserves the right to submit the item to the grading service that purportedly certified the item, for evaluation. Consignor may not withdraw the item from consignment prior to the grading service's evaluation of the item. Consignor acknowledges and agrees that, in the event the grading service identifies the item and/or holder and/or label as fake, the grading service's policy towards fake materials shall apply.

7. Consignor acknowledges and agrees that any items consigned shall secure any and all monies owed to GreatCollections, incurred before or after the date of the consignment, including but not limited to cash advances on this or other consignments, grading service fees, purchases, and interest accrued.

8. A Consignor is able to list a Minimum Bid on every coin/item consigned, according to the three options listed on the Consignment Form. It is up to the Consignor to verify that the correct Minimum Bids are entered as soon as their coins/items are uploaded to the GreatCollections website. Any corrections should be reported as early as possible before the end of the Auction. This Minimum Bid amount is disclosed on all items/coins listed at GreatCollections. Once an item has been listed for auction, Consignor may not withdraw any coin/item for any reason. If an item does not sell in auction, Consignor can request it to be returned (and not relisted in auction).

9. If the successful bidder or buyer is in default and GreatCollections is not satisfied that the amount due for any particular Consignor's lot[s] will be paid in full, GreatCollections reserves the right to take one or more of the following actions: (1) declare the sale null and void and return the coins/items to the Consignor; (2) declare the sale null and void and reoffer the coins/items in another Auction; and/or (3) proceed against buyer on behalf of Consignor. In addition, GreatCollections offers a return privilege to Buyers. Should your coin/item be

Up to Five Listings for One Nominal Fee: For one listing fee, GreatCollections will automatically relist any coin that doesn't sell (at the same minimum bid absent your approval), up to a maximum of four times without any additional listing fees. Additional listing fees are charged after five listings (on the 6th, 11th, 16th etc. listing). If you do not want your coins relisted, please let us know under "Special Instructions" on the reverse of this form.

Return of Unsold: In the unlikely event your coins do not sell in auction and you do not wish for them to be relisted, please contact us and we will return them to you.

Insurance: From the moment your coins arrive at GreatCollections, they are covered by our extensive insurance policy with Berkley Asset Protection, another benefit provided to all consignors at no cost.

Timing and Scheduling: Coins are generally listed on our website within 7-21 days of arriving at GreatCollections. Although we list coins almost daily, most listings occur on Monday afternoons and we will notify consignors by e-mail after each listing occurs.

PCGS, CACG & NGC Handling Fees: PCGS, CACG, and NGC all charge a handling fee per submission, which will be billed to your consignor account. If you have coins going to multiple levels of service, or U.S. and World coins (that will need to be split), please note, you will incur multiple handling fees. We will do our best to minimize the number of submissions for your consignment.

Minimum Bids: We offer three convenient ways to set Minimum Bids at GreatCollections.

1. You may select GreatCollections to establish a Minimum Bid based on our knowledge of the coin market. We usually set opening bids at 70% of what we believe the coins are worth in today's market. This is our recommended option that we have found to generate the most bidding activity while protecting you with a Minimum Bid.
2. You may select a percentage of the Values you have listed on the reverse of this form to use as Minimum Bids. Please check either the 50%, 65% or 80% option.
3. You may select that all coins start at a Minimum Bid of \$1. This is recommended for liquid/popular coins and is used regularly by dealers, investors and representatives of estates.

Regretfully, we cannot accept consignments where the Minimum Bids are higher than 80% of their listed values on this form. If your Minimum Bids are above the market price in our opinion, we may return your consignment without listing in auction. ICG coins can only be listed at GreatCollections with a \$1 minimum bid (ie. unreserved), regardless of your selection on the front of this form.

Consignment Proceeds: Checks are mailed within 30 days of your coin(s) selling. To confirm the payment date, please login to your account at GreatCollections, click on MyGC and "View Consignor Statements".

returned, we will cancel the sale and relist your item. In the event that GreatCollections cancels the sale of your coins/items or your coins/items are returned, all Listing Fees and Seller's Fees will be refunded to Consignor.

10. If you consign raw coins/items to GreatCollections, we will send your coins/items to a major third party grading service such as PCGS, CAC, NGC and/or ANACS and charge the grading fees against your account. GreatCollections extends our discounted rates for coin grading directly to members. For more information, including fees, please refer to the Raw Coin Consignment Form, which can be downloaded at www.greatcollections.com/forms.

11. GreatCollections shall remit to Consignor, within 30 days after the close of the Auction, the net proceeds, which equals the Hammer Price less Seller's Fees, Listing Fees, Grading Fees, other monies owed to GreatCollections by Consignor, Cash Advances Principal, and Interest for monies owed to GreatCollections by Consignor including but not limited to Cash Advances (in order). In certain instances, an introductory commission may be paid by GreatCollections to an agent of Consignor for referring the Consignment to GreatCollections; this commission is not charged to the Consignor.

12. In the event the Consignor's sales do not exceed fees or monies owed to GreatCollections, the Consignor agrees to pay GreatCollections all monies owed within seven days of the date of the invoice and/or settlement statement, after which date, compound interest at the rate of 10% per annum shall accrue on the outstanding balance.

13. GreatCollections will provide insurance for loss or damage for consigned coins while in the possession of GreatCollections and while any are being shipped back to the Consignor, subject to certain terms and exclusions (such as Earthquake coverage). In the event of an insurance claim, our insurance carrier will pay you the Fair Market Value, less the Seller's Fees and Buyer's Fees, based on the total insurance proceeds. This payment to you by the insurance carrier shall completely satisfy our obligations regarding the Consignments under this Agreement.

14. **California Law; Arbitration. This Agreement shall be governed by the laws of the State of California, excluding choice of law rules. Any claim or dispute arising out of the sale of coins/items by GreatCollections shall be settled by arbitration between the parties in accordance with the rules of the Professional Numismatists Guild (PNG) or if the PNG cannot or will not hear the matter, by the American Arbitration Association (AAA). The arbitrator(s) shall have the power and jurisdiction to order all discovery, including third party discovery, allowable by California and Federal law. The prevailing party (defined as the party that is awarded substantial and material relief on its claim or defense) in any such dispute shall be entitled to an award of fees and costs, including attorney's fees, as well as all other available forms of relief or damages. The arbitrator's award shall be final, and judgment may be entered upon it by any court having jurisdiction thereof. Any claim by consignor must be commenced within three months of the Auction date or Buy Now confirmation of the item at issue in the claim, or the claim is waived.**

15. This contract is the entire Agreement between the parties and supersedes all prior Agreements. The warranties and representations contained in this Agreement survive the date of execution by each party herein and the performance of all terms and conditions contained in this agreement.
